Minutes of Meeting August 15, 2023

A meeting of the Trustees of the Braidwood Fire Protection District was held on August 15, 2023, at the Braidwood Fire Station located at 275 W. Main St. in the city of Braidwood, Illinois at 9:00 A.M.
